Notice for the allocation of 80 partial scholarships

### Who can participate?

The scholarships are reserved for Italian and foreign students wishing to enroll in a three-year Bachelor's degree program, in Italian or English, at Accademia IUAD in Milan or Naples headquarters for the academic year 2025 - 2026.

The following are eligible to apply:

- all students holding an upper secondary school diploma or an equivalent foreign qualification
- students graduating in the 2024/2025 school year

### How to participate

To participate, the applicant must fill out the online form at [this link](#) or by scanning the QR code above and upload the required documents. Applications that do not include all the required documents will not be considered.

### Selection process

Selection will be based on

- Creativity
- Income bracket certified by ISEEU or Equivalent Economic Situation Indicator
- Prior academic performance of the applicant

### Required documents

- Privacy Policy and Disclaimer Statement (Attachment 1)
- copy of the identity card or other identification document
- ISEEU / ISEEU-P Certification *or Equivalent Economic Situation Indicator (if not submitted, the student's income bracket will be considered within the higher range)*
- BEST 80 Project. Candidates must answer the following question: "What do you see yourself doing in 10 years? Describe your ideal job". PRESENTATION MODE:
  - A collage or a mood board containing words and pictures; it can be produced by hand or with any software
  - a 15-30 second descriptive video in the Reel/Story format; created with any software

### Additional documents (optional)

The following documentation, if included in the scholarship application, will be evaluated during the selection process:

- a strong high school GPA
- foreign language certificates or certificates of participation in projects abroad

- This call is aimed exclusively at students who intend to enroll in the academic year 2025 - 26. Students already enrolled at Accademia IUAD who must repeat the first year of the course are excluded from the call.
- IUAD reserves the right to award a smaller number of scholarships if the quality of the projects received is deemed insufficient.
- IUAD reserves the possibility to share deserving projects on its social platforms for demonstration and promotional purposes.
- The scholarship amount will be deducted exclusively from the first year's tuition (not applicable on the advance payment)
- Students who do not graduate at the end of the school year 2024-25 lose the awarded scholarships.

## INFORMATION NOTICE ON THE PROCESSING OF PERSONAL DATA PURSUANT TO ART. 13 REG. EUR. 679/2016 (GDPR)

The European Regulation No. 679 of April 27, 2016 ("General Data Protection Regulation" or GDPR) and Legislative Decree No. 196/2003, as amended by Legislative Decree No. 101/2018, provide for the protection of natural persons during the processing of personal data.

### DATA PROVISION METHODS

The processing of such information is essential for the above-mentioned purposes. Data provision is optional but necessary; otherwise, the service provided by the Controller cannot be performed.

### DATA RETENTION PERIOD

The data provided by the data subject will be retained for the time necessary to fulfill contractual, accounting, and legal obligations, after which they will be deleted and/or destroyed unless further relationships are established with the Controller. Essential data will still be retained beyond the ten-year prescription period after the termination of the relationship to fulfill legal obligations and to allow former students to access their academic records.

### DATA PROTECTION OFFICER (DPO)

The Controller does not use a Data Protection Officer (DPO).

### PROCESSING LOCATIONS AND CATEGORIES OF RECIPIENTS

Personal data acquired upon enrollment and/or through specific collection methods are processed at the operational headquarters of the Controller and in any other place where the parties involved in the processing are located. Data will be communicated only to the competent authorities, will not be disclosed, and will not be transferred to non-EU countries.

In the management of the data subject's information, specific categories of authorized persons, designated by the Controller as internal and/or external processors, may become aware of the data. These individuals are identified in writing and provided with specific written instructions regarding data processing.



#### EMAIL ADDRESS

Data is processed at the operational headquarters of the Controller and within IT systems used for email communication. Through these systems, data may be communicated to entities outside the EU in countries where the European Commission allows cross-border transfers due to an adequate level of protection (pursuant to Art. 45 GDPR).

To facilitate guidance, education, and job placement, including abroad, and where disclosure is necessary to achieve the educational objectives of the Academy (or at least not incompatible with them), the Controller may communicate and/or disseminate, including electronically and to private entities, data regarding the academic results (intermediate and final) of data subjects. This includes enabling them to receive invitations to meetings, events, conferences, and other academic-related gatherings.

#### PROFILING AND OTHER USES OF DATA

The data provided by the data subject will not be subject to profiling as per Art. 22, paragraphs 1 and 4.

#### DATA SUBJECT RIGHTS

Each data subject is entitled to the following rights:

- Right to access data (Art. 15)
- Right to rectification (Art. 16) and deletion ("right to be forgotten") (Art. 17)
- Right to restriction of processing (Art. 18)
- Right to receive notification in case of rectification or deletion of personal data or restriction of processing (Art. 19)
- Right to data portability (Art. 20)
- Right to object (Art. 21)
- Right not to be subject to automated decision-making, including profiling (Art. 22)
- Right to lodge a complaint with the Data Protection Authority (Art. 51)

To exercise the above rights, data subjects may submit a request using the contact details of the Controller indicated in this document. Requests are free of charge and will be processed as soon as possible, in any case within one month. If the Controller fails to fully or partially respond to the requests, the data subjects have the right to file a complaint or appeal to the Data Protection Authority under the terms and conditions set forth in the GDPR.

It is noted that, given the specific nature of the relationship established and the Controller's role as an educational institution, students cannot request the deletion of their data unless they terminate the existing relationship. However, they may at any time request the updating of their personal data.

#### POTENTIAL PERSONAL DATA BREACH

If a personal data breach is likely to result in a high risk to the rights and freedoms of data subjects, the Controller will communicate the breach without undue delay (Art. 34 GDPR).

The above communication is not required if one of the following conditions is met:

1. The Controller has implemented appropriate technical and organizational protection measures that were applied to the breached personal data, in particular rendering the data unintelligible to unauthorized persons (e.g., encryption).
2. The Controller has taken subsequent measures to eliminate the high risk for data subjects' rights and freedoms.
3. Such communication would require disproportionate effort. In this case, a public communication or similar measure will be adopted to inform data subjects with the same effectiveness.

#### CHANGES TO THE PRIVACY POLICY

The Controller reserves the right to modify this Privacy Policy at any time, informing data subjects as necessary, by sending a notification via one of the contact details available to the Controller.

Therefore, it is recommended to regularly check the website and/or the Controller's office, referring to the date of the last modification indicated at the bottom.

If the modifications affect processing based on consent, the Controller will collect the data subject's consent again, if necessary.

#### ADDITIONAL INFORMATION

Further information regarding the processing of personal data can be requested at any time from the Controller using the provided contact details.

If the Controller intends to process the data subject's personal data for a purpose other than that for which they were collected, prior to such further processing, the Controller will provide relevant information regarding this different purpose and any additional relevant information.
